APPLICATION FOR SPECIAL LICENSE PLATE

1. Personal property tax receipt or statement from county assessor that no taxes are owed must accompany application if current license plate is expiring within sixty (60) days.
2. Current license plate must be returned to the Division of Motor Vehicles after the special plate is received. After issuance of the special plate, the exchanged plate is canceled and cannot be transferred to another vehicle. There are no refunds.
3. Vehicle must have a West Virginia title and license plate in the name of the applicant before a special plate can be issued.
4. Use fee chart on reverse side to calculate fee. The fee is based on your present license plate expiration so you do not have to wait until your plate is ready to expire to order a special plate.
